

TOWN OF MIDALE

BYLAW 2017 - #03

A bylaw of the Town of Midale in the Province of Saskatchewan, to provide for the Emergency Conservation and Water Use Restriction Bylaw with in the Town of Midale.

The Council of the Town of Midale, in the Province of Saskatchewan enacts as follows:

Short Title

1. This bylaw may be cited as the Emergency Conservation and Water Use Restriction Bylaw in the Town of Midale.

Purpose

2. The purpose of this bylaw is:
 - a) to ensure the health and safety needs of the community are being met during times of an emergency
 - b) to allow for certain non -essential uses of water to be prohibited or restricted to ensure sufficient water is available to meet the basic needs such as cooking ,cleaning, bathing, toilet flushing, and maintain sufficient flows for fire protection.
 - c) to minimize water consumption for daily use as identified above Subsection (b)

Definitions

3. in this Bylaw:
 - a) "Designated Officer" means an employee or agent of the Municipality appointed by Council to act as a municipal inspector for the purposes of this bylaw.
 - b) "Town Manager" means the person appointed as the administrative head of Council.
 - c) "Municipality" means the Town of Midale;
 - d) "Town Water" means potable water supplies by the Town's Treatment Plant Reservoirs
 - e) "Conservation" means the careful utilization in order to prevent depletion:
 - f) "Conservation Measure "means any act to reduce the utilization of water:
 - g) "Council" means the elected Mayor and Councillors of the Town of Midale.
 - h) "Minimize" means to reduce water consumption to the lowest level possible

Authority

4. The Town Manager is hereby authorized to:
 - a) Administer the Bylaw.
 - b) Ration water use by having watering schedules for the watering of lawns and gardens during the summer months.
 - c) Immediately declare any conservation measures as identified in this Bylaw. and
 - e) Provide approval for any exemption to any of the conservation measures identified in this Bylaw
5. Enforcement of this Bylaw is hereby delegated to the "designated Officer for the Town.
6. The designated Officer for the Town is hereby authorized to further delegate the administration enforcement of this Bylaw to a Bylaw Enforcement Officer.

Prohibition:

7. Conservation measures that may be declared:
 - a) Closure of Truck Fill
 - b) Closure of Car Washes
 - c) Closure of laundromats

- d) Prohibition on all outdoor irrigation, except for area using reclaimed water.
- e) Washing of sidewalks, driveways, patios and other paved areas.
- f) Outdoor use of water based play apparatus.
- g) Filling swimming pools, hot tubs, fountain spas .or other outdoor water features.
- h) Washing automobiles, trucks, trailers, and other vehicles.
- i) Watering lawns and gardens.


Offenses and Penalties

8. Every person who contravenes any provision of this bylaw is guilty of an offense and will be fined up to \$ 1,000.00 per occurrence.
