WATERWORKS RATE POLICY

On February 13, 2024, Council passed a bylaw (Bylaw No. 2024-01) to fix the rates to be charged for the use and consumption of water and to fix the rates to be charged by way of rent and service charge for the use of the sewer.

Under the waterworks rate policy bylaw, the water rate of \$35.00 for the first 14 cubic meters of water per month and \$1.92 per cubic meter in excess of 14 cubic meters per month, as adopted under the Water and Sewer Rates Bylaw, dated February,13, 2024.

Council is continuing with upgrades each year to the water treatment plant.

The objective of the waterworks rate policy is to work towards waterworks that are self-financing, where the users pay for the cost of the service. To accomplish this, rates will periodically have to increase following the cost of upgrading the plant as indicated in the 2015 waterworks assessment required by *The Water Regulations, 2002*.

This waterworks rate policy will work towards a financially independent waterworks that will not put demands on the municipal general reserve fund.

WATERWORKS CAPITAL INVESTMENT STRATEGY

The objective of the waterworks capital investment strategy is to address anticipated waterworks infrastructure maintenance, the immediate drinking water infrastructure problems and future infrastructure replacements in a timely fashion so as to ensure the municipal waterworks provides safe drinking water to residents and businesses. The strategy uses the 2015 waterworks system assessment that was required by Saskatchewan Environment for infrastructure planning and the Asset Management Policy and Waterworks Quality/Quality Control Policy.

This capital investment strategy will ensure that safe drinking water can be provided to the residents and businesses in the community in the present and future.
